BUSINESS ENTERPRISE CERTIFICATION

San Jose/Evergreen Community College District, in compliance with California Code of Regulations Section 59500 et.seq., requests your response to the following questionnaire, which is for informational use only. Using the following guidelines, please determine the classification under which your business qualifies.

SBE - SMALL BUSINESS ENTERPRISE

Generally, your firm is considered by the State of California to be a Small Business Enterprise if it has (a) 100 or fewer employees and (b) average annual gross receipts of \$15 million or less over last three tax years.

SB-PW - SMALL BUSINESS for the purpose of PUBLIC WORKS

Generally, your firm is considered by the State of California to be a Small Business for the purpose of Public Works if it has (a) 200 or fewer employees and (b) average annual gross receipts of \$36 million or less over last three tax years. "Public Works" is defined as "the erection, construction, alteration, repair, or improvement of any public structure, building, road, or other public improvement of any kind."

MBE - MINORITY BUSINESS ENTERPRISE

A Minority Business Enterprise is a business concern which is at least 51% owned by one or more minority persons (Native American, African American, Asian/Pacific American or Hispanic American). A publicly owned corporation qualifies if at least 51% of the stock is owned by one or more minority persons. Management and daily business operations must be controlled by one or more such individuals. The firm must have its home office located in the United States and it must not be a branch or subsidiary of a foreign corporation, firm or other business.

WBE - WOMEN OWNED BUSINESS ENTERPRISE

A Women Owned Business Enterprise is a business concern which is at least 51% owned by women. A publicly owned corporation qualifies if at least 51% of the stock is owned by women. Management and daily business operations must be controlled by one or more such individuals. The firm must have its home office located in the United States and it must not be a branch or subsidiary of a foreign corporation, firm or other business.

DVBE - DISABLED VETERANS BUSINESS ENTERPRISE

A Disabled Veterans Business Enterprise is a business concern which is at least 51% owned by disabled veterans. A publicly owned corporation qualifies if at least 51% of the stock is owned by disabled veterans. Management and daily business operations must be controlled by one or more such individuals. The firm must have its home office located in the United States and it must not be a branch or subsidiary of a foreign corporation, firm or other business. The State of California's Department of General Services, Office of Small Business and Disabled Veteran Business Enterprise Services defines "disabled veteran" as a veteran of the military, naval or air service of the United States with a service-connected disability of at least 10% or more and who is a resident of the State of California.

DSE - DISABLED BUSINESS ENTERPRISE

A Disabled Business Enterprise is a business concern which is at least 51% owned by disabled persons. A publicly owned corporation qualifies if at least 51% of the stock is owned by disabled persons. Management and daily business operations must be controlled by one or more such individuals. The firm must have its home office located in the United States and it must not be a branch or subsidiary of a foreign corporation, firm or other business. The ADA defines a person with a disability as a person who has a physical or mental impairment that substantially limits one or more major life activity.

VTE - VETERANS BUSINESS ENTERPRISE

A Veterans Business Enterprise is a business concern which is at least 51% owned by veterans. A publicly owned corporation qualifies if at least 51% of the stock is owned by veterans. Management and daily business operations must be controlled by one or more such individuals. The firm must have its home office located in the United States and it must not be a branch or subsidiary of a foreign corporation, firm or other business. The

Veterans' Administration defines a veteran as a person who served in the active military, naval, or air service and who was discharged or released under conditions other than dishonorable.

LOC -- LOCAL BUSINESS ENTERPRISE (INTRA-DISTRICT OR SANTA CLARA COUNTY OR WITHIN 200 MI RADIUS)

A Local business is a business concern which maintains a permanently-staffed office available to provide services to the District within one of the following proximities:

1. **Intra-District** – the address is within the service area for the San Jose Evergreen Community College District; or
2. **Santa Clara County** – the address is within the boundaries of Santa Clara County; or
3. **200 Mile Radius** – the address is within a 200 mile radius of the District offices at 40 South Market St., San Jose, CA 95113.
